Neighborhood Conservation Plan Moves Forward

BMCA has made progress toward the goal of gaining a share of the funds Arlington County apportions for Neighborhood Conservation (NC) projects each year. To qualify for this funding, each Civic Association must complete and submit a NC Plan. The plan should be based on the preferences and concerns of the residents in the neighborhood.

To participate in this process, BMCA distributed NC surveys to over 450 homes earlier this Spring. To date, more than 180 surveys have been returned (approximately 40%). The NC Plan team of volunteers has begun to tabulate the survey results. If you have not yet completed your survey, there's still time to make your opinions known. Please return the completed survey to any of the NC Plan team members listed on the cover memo. If you need another copy of the survey, please call Matt Doyle at 294-4922.

The survey is designed to collect opinions on such topics as land use and zoning, traffic, parking, sidewalks, streets and lighting, and community services. The responses to the survey will help us to define the neighborhood's needs, enabling us to complete a NC Plan. We still need help in analyzing the survey results, and later, in writing the plan. Breaking News:

Abduction Attempted in Bluemont Park

On May 12, at approximately 3:00 p.m., a female babysitter was walking on the W&OD bike trail just north of Route 50 with an infant. She was approached by a white male in his 20s, approximately 5'7" tall, medium build with short blond hair. After a short conversation, the suspect began pulling the babysitter and the child toward Four Mile Run. The babysitter was able to free herself from the suspect and flee with the child. At press time, police are still looking for the suspect.

It is appropriate to remember the advice provided to us for last May's newsletter by Cpl. Robert Golladay, BMCA's liaison officer from the First District, Arlington County Police Department, after a separate set of crimes on the bike trail:

While we are making the community aware of these incidents, in no way are we suggesting that you can't use the bike trails. If anything, we're trying to encourage you to use the paths, but to follow a few commonsense suggestions:

- Exercise with a friend. It's safer and more fun.
- Carry a cell phone to contact police or emergency services if you or others need assistance.
- Exercise in well-traveled areas.
- Use the paths during daylight hours; County parks are closed after dark.
- If you see someone or something suspicious, get away and call 9-1-1.
- Be aware of your surroundings. It's much easier for police to find you if you can specify where you are.
- If you see people entering the parks at night, especially in groups, please call the police immediately.

The Northern Virginia Regional Park Authority is currently accepting comments on the draft of the 2005 to 2009 Capital Improvement Program (CIP) for all of the Regional Parks. The CIP typically funds new development, land acquisitions and park renovations. For this CIP cycle, roughly \$1.4 mil has been slated for Upton Hill for the purpose of swimming pool and miniature golf renovations. We welcome your comments and suggestions.
