### Crime Update

The last February newsletter reported a pattern of residential burglaries in western Arlington County. The situation apparently was resolved on March 19, when police arrested a man who broke into a home in the Arlington Forest neighborhood. A woman surprised an intruder in her house, causing him to flee out the back door. Because she called 911 immediately, the police were able to set up a perimeter and to apprehend the suspect.
