New Playground Planned for Bluemont Park

The children's playground at Bluemont Park is one of the oldest such facilities in Arlington. BMCA and neighbors have repeatedly urged the County to update the playground equipment and make other needed improvements. The Parks Department has begun the process to design the new playground.

The Bluemont playground project will be a full replacement with new equipment, new surfacing, accessible pathways compliant with ADA, and the appropriate storm water management for the site. The entire project, from the beginning of the design process through the end of construction is expected to take approximately 18 months. In response to Parks Department efforts to gather community input, a number of neighbors have formed a working group to develop design suggestions.

Bernadette Grullon, the Parks Department's Landscape Architect Supervisor, will discuss the playground design process at the BMCA general meeting on October 20.

BMCA Emergency Preparedness Committee Stands Up

BMCA has formed an Emergency Preparedness Committee, with five members including chair Yvonne Caruthers. The mission of this committee is to develop and initiate plans and programs that will enhance the safety and well being of the residents of Boulevard Manor in times of neighborhood crisis and emergency situations.

The committee has been exploring better was to communicate emergency preparedness issues to the community, ways that the community can be better prepared for emergency situations, and also several other new initiatives such as block captains and increased participation in Community Emergency Response Team (C.E.R.T.) training. The committee will provide a briefing on status and initiatives at the October 20 BMCA general meeting.

Traffic Calming Planned for 4th Road N.

As announced in the June newsletter, the County Department of Public Works (DPW) determined that 4^{th}

Road N. between N. Manchester Street and N. Montague St. is eligible for traffic calming funds. The determination was based on measurements of traffic volume, average speeds, and other factors. In accordance with the established neighborhood traffic calming (NTC) process, affected residents formed a working group and participated in four meetings under the guidance of Ron Hicks of DPW. BMCA vice president Paul Svercl served as point of contact for the project.

The working group meetings established consensus on proposed traffic calming measures based on the 2007 NTC Manual and recommendations of DPW's design team. A petition circulated among the affected residents on 4th Road N. and the 400 block of N. Manchester St., resulting in 100 percent approval for the proposed plan.

The BMCA Board has reviewed the 4th Road N. NTC

VDOT Removes Graffiti from Arlington Boulevard Noise Barrier

Responding quickly to a request from BMCA, the Virginia Department of Transportation addressed graffiti that had been painted on the noise wall between U.S. Route 50 and 1st Street N. VDOT directed a contractor to remove the apparently gang-related markings that covered approximately 1,000 square feet on both sides of the wall. The Arlington Police are investigating the potential gang activity.

Draft Neighborhood Conservation Plan Reviewed by County Staff

Earlier this year, BMCA presented our draft Neighborhood Conservation Plan to county staff for comment. Their reaction was positive and they offered some recommendations for simple improvements to help ensure approval of the plan. The plan is now ready for final refinements before presentation to the Neighborhood Conservation Advisory Commission, the Planning Commission, and finally, the County Board. At the October 20 BMCA general meeting, a motion will be presented for the membership to endorse the draft plan so that BMCA may proceed through the County's approval process. The draft plan is available for viewing or printing at www.boulevardmanor.org. It is anticipated that the plan will be approved early in 2009 so that Boulevard Manor may participate in neighborhood conservation projects expected to be funded in late 2009.
