

BMCA Neighborhood Conservation Plan Approved by County Board

In June, the Arlington County Board approved the Neighborhood Conservation Plan (NCP) developed by BMCA. Former BMCA president Matt Doyle's presentation of the NCP was complimented by members of the Board. Having secured this final approval, the Civic Association (or individual neighbors) now can seek county funding for neighborhood conservation projects.

The completed NCP is the culmination of several years of effort by many neighborhood volunteers. BMCA thanks the dozens of neighbors who assisted in the neighborhood survey, in writing and editing the chapters of the NCP, and in presentations to various commissions as well as the County Board. The final NCP is available on the BMCA web site, www.boulevardmanor.org.

The first action under the NCP will be the installation of signs identifying Boulevard Manor near three or four entrances to the neighborhood. A committee appointed by the BMCA board has worked with local artist Peter Lindeman and with county staff to design the signs and choose appropriate locations. The design (below) was displayed at the neighborhood picnic and has been approved by the BMCA board.

The NCP team has moved quickly to try to secure funding in the next round of county funding for neighborhood conservation projects. The first proposed project focuses on the intersection of N. Montague St. and 1st St. N. and nearby segments of both streets. Working with county planners, architects, and engineers, the NCP team has proposed improvements aimed at enhancing the neighborhood's pedestrian-friendly qualities, increasing nighttime lighting in an especially dark area, and slowing fast-moving traffic. The plans include a re-designed intersection, narrowed intersections along Montague Street, Carlyle lighting, crosswalks, new green space, "gateway" (faux brick) surfacing, and new signage. A detailed proposal has been presented to the neighbors in the affected area,

The NCP team will continue to work with neighbors and with county staff to develop projects that can be funded under the neighborhood conservation program. For the next round of funding (June 2010), the NCP Team may pursue a revised version of the Montague/1st project or a separate project.

The neighborhood working group continued to provide feedback as county staff finalized the project designs. The plans include complete redevelopment of the playground site and all-new equipment themed to the dairy farm and railroad elements of the neighborhood's history. Construction is expected to begin approximately January 2010, with the new playground ready for use by next summer.

Traffic and Transportation Matters

In July, the Arlington County Board approved funding for the installation of traffic calming measures on 4th Road N. Construction is scheduled for spring 2010. The elements of the 4th Road N. project include nubs, parking lines, marked crosswalks, a major modification of the intersection of 4th Road N. at N. Montague St., and new signage.

BMCA transportation committee chair Paul Svercl recently communicated to the Virginia Department of Transportation (VDOT) several neighborhood concerns associated with Arlington Boulevard/U.S. Route 50. On at least two matters, VDOT is taking immediate action:

- 1. Responding to concerns about pedestrian safety, VDOT reviewed accident data for Route 50 at N. Manchester and N. Montague Streets. VDOT will work with the county to identify the feasibility and eligibility of improvements at both intersections under the Highway Safety Improvement Program.
- 2. VDOT will remove invasive trees from the strip between Route 50 and the frontage road. Trees blocking signs along Route 50 will be trimmed.
