### **BMCA Presses County for Action on Reevesland**

In 2001, Arlington County purchased the Reeves family property at 400 N. Manchester St., ostensibly to incorporate the land and its 110-year old house into Bluemont Park. No decision-making for use of the property has even begun because the County Parks Department has linked such determinations to the long-delayed revision of the Bluemont Park master plan. BMCA has repeatedly drawn the County government's attention to the former Reeves property. Civic Association action led to the designation of Reevesland as an Historic District in 2004 and to remedial maintenance for the former Reeves home and other structures on the property.

Last year, BMCA began urging the County to the end the delay. In August 2009, BMCA Reevesland Committee chairman Larry Goldschmidt met with County Board Chairman Barbara Favola, joining other Arlingtonians to express concerns about the property. In November, BMCA president Phil Klingelhofer sent a letter to the County Board to bring attention to new maintenance problems at Reevesland. Parks staff did respond, addressing some of the problems.

In January 2010, the Reevesland Committee met with Michael Leventhal, Arlington County's Historic Preservation Program Coordinator, to discuss the possibility of installing interpretive signs at the site. Mr. Leven-

bors' unease with the current status of Reevesland, specifically the continuing deterioration of all structures, the worsening visual character of the Historic District, and the absence of County planning for the property.

Following up these discussions, the
Reevesland Committee prepared a letter to the County Board expressing
BMCA's many concerns. The letter,
which can be viewed at
www.boulevardmanor.org, urges the
County to initiate a study of possible
uses of the Reevesland house and provides suggestions
for completing the study most cost-efficiently.

Phil Klingelhofer has requested meetings with County Board members to express neighbors' concerns personally. The Reevesland Committee will continue pressing the County Board for action, following up on the project for interpretive signs, and monitoring conditions at the Reevesland Historic District.


#### Please Shovel Snow from Sidewalks

#### Neighborhood Signs to be Installed

As described in the October 2009 *Between the Boulevards*, a BMCA committee prepared designs for neighborhood signs (see illustration) and presented them at the neighborhood picnic. Funding for the signs was approved by the County's Neighborhood Conservation Advisory Committee in December 2009.

The Signs Committee has been working with the County to move toward production and installation, which are subject to County Board approval that is anticipated in February 2010. Signs will initially be installed at three neighborhood entrances: Wilson Blvd./Livingston St., Wilson Blvd./Manchester St., and Manchester/1<sup>st</sup> Street/Arlington Blvd. A fourth sign location - somewhere near the Arlington Blvd./Montague St./ Nottingham St. entrance – remains under discussion.

Signs are part of Arlington's Neighborhood Conservation Program, which is funded by special bonds. With our Neighborhood Conservation Plan finalized in 2009, Boulevard Manor will join most other Arlington neighborhoods that have signs welcoming residents and visitors and generally denoting boundaries. The County funds the initial landscaping for sign installation; the neighborhood is responsible for maintaining plantings thereafter.

## Re-Constructed Bluemont Park Playground to Open Summer 2010

In October 2009, the County Board approved a \$650,000 contract for reconstruction of the playground in Bluemont Park. The selected construction firm has worked successfully with Arlington County on past projects. Initial construction activities have begun. Park users can expect to see construction signs and fencing up in the next weeks. The delivery schedule projects that the playground will be available for use this summer.

The new playground will feature separate themed play areas for tots and school-age children, a sandbox with a hand pump, benches, picnic tables, paths, a drinking fountain, a ground hydrant and landscape boulders. Designs for these features (see illustrations) are based on community input developed in a collaborative conceptual design process that began in October 2008. Participants sought to honor Bluemont's heritage by theming the new tot playground around Torreyson-Reeves Dairy Farm – which used to operate where the park now stands – and by including trains in the elementary-age playground to honor Bluemont Junction.

- Led cleanup efforts to address trash and overgrown vegetation at the Manchester Street/Arlington Boulevard neighborhood entrance, with further beautification projects planned
- Coordinated with County Board members, staff, and historic preservation groups to address the upkeep and future uses of the former Reeves farm property at 400 N. Manchester St.
- Hosted four social events the Easter Egg Hunt, July 4 Ice Cream Social, Neighborhood Picnic, and Holiday Caroling – to engage neighbors, with plans to add a fifth event in 2010

## **Street Improvements Planned**

When BMCA's Neighborhood Conservation Plan (NCP) was approved by the County Board in June 2009, Boulevard Manor became eligible for (1) neighborhood signs and (2) neighborhood conservation program funding for approved projects from the list in our NCP. Our NCP Committee has gained experience in the county's design process and in obtaining residents' approval for proposed projects. BMCA will be forwarding a revised request for Carlyle street lights and pedestrian safety elements for Montague and First Streets in spring 2010. In accordance with affected residents' wishes, the county design team will be directed to avoid project elements that reduce street parking.

Affected residents along Montague and First Streets will be asked to review the revised plan and to provide a survey response that demonstrates neighborhood concurrence with the design. If all requirements are met, the project will move through an approval process that includes two advisory commissions and, finally, the County Board by June 2010. Dori and Byron D. Byron moved to N. Madison St. in 1978. Four years later, Dori became BMCA president. Accomplishments during her term included establishment of a Neighborhood Watch program. Dori has continued to serve the civic association since then in many vital roles. Her service has included chairing the Membership Committee for more than a decade and taking the lead in many of BCMA's social events. Dori and Byron have moved from Boulevard Manor to a condominium in Arlington to "downsize and make life easier."
