Learning Garden Proposed for Reevesland

On January 19, 2011, Arlington County approved a proposal by neighborhood residents for a Learning Garden to be planted on the historic Reevesland property at 400 N. Manchester St. After many meetings, the County responded favorably to a letter signed by more than 220 neighbors requesting permission for a Learning Garden on the County-owned property. The proposal was also endorsed by the BMCA board.

The Reevesland Learning Center Steering Committee, chaired by Joan Horwitt, helped shepherd the Learning Garden proposal through the County's decision-making process. Boulevard Manor neighbor and County Park Service Area Manager, Lyndell Core, provided extensive assistance.

The Learning Garden is an expansion of the highly successful "LAWNS 2 LETTUCE 4 LUNCH" project that was organized in 2010. Last year, more than 125 people volunteered to grow lettuce for celebratory lunches at Ashlawn Elementary School in June and again in November. Volunteers included families of Ashlawn students, neighbors, and Ashlawn staff. A sizeable portion of fresh lettuce was donated to the Arlington Food Assistance Center. The Washington Post and Sun Gazette featured news stories about this innovative, community-school program.

Beginning in March 2011, Ashlawn students, teachers and neighbors will plant the new Reevesland Learning Garden. Comprising eight raised growing beds, the Learning Garden will be planted exactly where our late neighbor, Nelson Reeves, maintained his iconic vegetable garden for decades. This project represents the first official use of the property since the County purchased it from the Reeves family in 2001.

The goals of the Learning Garden and LAWNS 2 LETTUCE 4 LUNCH are to promote positive attitudes among our children about growing and eating healthy foods and, equally important, to build new,

BMCA Urges County to Move Forward with Neighborhood Conservation Projects

BMCA President Mike McComis has written a letter to the County Manager's office urging the continuation of a traffic calming project on 1st Street N. that neighbors have pursued under the Boulevard Manor Neighborhood Conservation Plan (NCP). The letter and supporting data can be viewed at the BMCA web site, www.boulevardmanor.org.

As has been described in previous newsletters, neighbors worked for more than a year to build a consensus for changes that will make 1st Street N. and N. Montague St. safer and more attractive. In October 2010, County staff informed the neighborhood that studies had confirmed that traffic calming measures ("speed humps") were indicated. Early this month, however,

the Neighborhood Traffic Calming Commission informed residents that the traffic calming project for 1st Street was being held up. The next step of the project – a petition that must be approved by a supermajority of affected residents – cannot proceed because an anonymous individual outside the neighborhood has challenged the validity of the underlying traffic data.

With the support of the Civic Association Board, BMCA President McComis has sent a letter to Deputy County Manager Marsha Allegier. The letter asserts that the County's reaction to the challenge represents an impermissible departure from established procedures. BMCA will continue to advocate for neighbors' right to pursue appropriate NCP projects, including those that have been demonstrated to meet the requirement of the county's Neighborhood Traffic Calming program.

Reevesland Working Group Reports to County Board

In addition to expressing support for the Reevesland Learning Garden proposal (see page 1), BMCA has continued to actively pursue commitments from Arlington County for maintenance and acceptable future use of the former Reeves home. Neighborhood representatives participate in the Reevesland Working Group, tasked with providing solutions to the County Board for the reuse of Reevesland. On December 2, 2010, the working group forwarded a report to Jay Fiset, who at the time was chairman of the County Board.

In their report, the working group identified the following options (as well as combinations of these options):

- ▶ Lease the house and garage to a non-profit organization.
- ▶ Develop Reevesland as an agricultural demonstration project.
- ▶ Develop Reevesland as a sustainability /green building demonstration project.
- ▶ Allow BMCA to use the house as a community center provided that the BMCA can secure Neighborhood Conservation funds for the renovation of the house.
- ▶ Lease to a private Individual for residential use.
- ▶ Leave the house mothballed indefinitely.

Although the last option is considered unacceptable to the BMCA community, the working group chose to include it within the range of possibilities in order to

explicate why it is an untenable solution. The BMCA Board has voted to advance the restoration of Reevesland and surrounding property as its next NCP-funded project and is currently working through the Neighborhood Conservation process.

BMCA has not been able to confirm that the County Board has yet reviewed the report of the Reevesland Working Group. BMCA will continue to advocate for more rapid progress in decisions for Reevesland with the goal of again making the former Reeves property a valuable part of the community.
